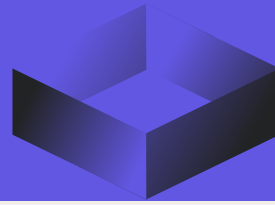
DOCUMENTS REQUIRED FOR STARTING BUSINESS IN INDIA :

- Copy of Rental Agreement / EB Card Copy of Registered Office
- Copy of Latest Bank Statement
- Copy of Latest Utility bills / Electricity bill, Water bill etc (but bill shall not be older than 2 months)
- If Subscribers and Directors do not have a DIN, then it is mandatory to attach proof identity and residential address.
- Passport-size photograph
- PAN Card and Residence proof of Directors of the Company
- Specimen Signature (blank documents with directors signature only)
- Authorization Letter for GST registration

FSSAI REGISTRATION

FSSAI Registration is a basic license to take permission which is required to operate a food related business. This license is required for manufacturers, suppliers, transporters, distributors etc related to food business.

- **Get Basic FSSAI License < 12 lakh/year within 1 day only**
- **Get State FSSAI License of 12 Crore – 20 Crore/year within 5 working days only**
- **Get Central FSSAI License >20 Crore/year within 5 working days only**



UDYOG AADHAAR/ UDYAM/ MSME REGISTRATION

MSME stands for Micro, Small and Medium Enterprises. These are the enterprises which are primarily engaged in the production, manufacturing, processing, preservation of goods and commodities.

DOCUMENTS REQUIRED FOR UDYAM/ MSME REGISTRATION:

- Application form with passport-sized photographs.
- Passport, voter id card, Aadhaar card, Driving license, Utility bills (water & electric bills).
- Business PAN card.
- Business establishment certificate.
- Income proof
- Bank details.
- Last 6 months Bank Statement.
- Sales & purchase Bill Copies
- Rent or lease agreement.
- NOC from the landlord.
